

## **Rules of Play**

- Essex, Ontario, N8M 2X6, using a Random Number Generation (RNG) system from all raffle numbers sold for the draw.

Raffle duration: March 9<sup>th</sup> 2026 – May 8th 2026

### Jackpot Draw

- The jackpot draw will take place on Friday, May 8th, 2026 at 10:00am
- The raffle will take place online starting March 9<sup>th</sup> 2026 at 12:00am
- Ticket prices as follows:
  - 1 for \$5
  - 20 for \$20
  - 100 for \$50
  - 300 for \$100
- Tickets will be sold online using an electronic raffle system (ERS) approved by the Alcohol and Gaming Commission of Ontario (AGCO) and operated by the charitable gaming supplier Raffle Nexus.
- The draw will be conducted using an electronic raffle system (ERS) approved by the AGCO and provided by Raffle Nexus. The winning ticket will be selected by a random number generator software integral to the ERS from all lottery numbers sold for the draw. A neutral third party (that is, a person who has not purchased a ticket) will initiate the draw sequence using the ERS dashboard.
- Ticket purchaser must be in the Province of Ontario and at least 18 years of age at the time of ticket purchase. Tickets cannot be purchased in the name of persons under 18 years of age. On-line purchasers may be required to activate the location app on their device for geo-location verification.
- After buying, on-line patrons will be provided a confirmation email with their 50/50 registered numbers from a Random Selection System. No specific numbers can be given as numbers are generated randomly.
- The amount of the 50/50 prize will be determined based on the number and value of tickets purchased. The winner receives 50% of the total dollars of the 50/50 Raffle ticket sales.
- Pursuant to AGCO Regulations the following individuals including their immediate families living at the same residence are prohibited from purchasing a ticket and are not eligible to win:
  - Any person with a connection to WETRA who has any involvement in the management and/or conduct of the licenced lottery event is not eligible to purchase any tickets or win any prizes.
- All tickets purchased between March 9th 2026 at 12:00 am and at or before May 7 2026 11:59 pm will be entered into the 50/50 draw.
- The jackpot draw will take place on May 8<sup>th</sup> at 10:00 am

The winner will be notified by phone or email and provided instructions on how to claim their prize. The winner may claim their prize by contacting WETRA at 519-726-7682 or email at [info@wetra.ca](mailto:info@wetra.ca).

The winning ticket holder has 6 months in which to claim their prize from the date of the draw their ticket was purchased for.

The winner must provide his/her name, address and phone number with picture identification for our report sheet.

By purchasing tickets for the WETRA 50/50 Electronic Raffle, winners agree to the use of their name and likeness without compensation for any promotional activity related to this or any future raffle.

Once the winner is verified, and provides identification with photo ID, they will be given a cheque in the amount of the declared prize which is a 50% of the total sales for the draw. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided.

In the event that no winner comes forward, any prizes which are not claimed will be secured or placed in safekeeping for a period of six (6) months from the date of the draw. After that time period has elapsed the prize will be donated to a charity other than WETRA with the approval of the Alcohol and Gaming Commission of Ontario (AGCO).

In the unlikely event that the draw is postponed due to technical difficulty, power interruption, emergency or other unforeseen event, WETRA will conduct the draw and announce the winner at the earliest possible opportunity after the situation as been remedied.
